Fund objective and investment policy change

I am writing to you because you are invested in the VT Momentum Diversified Growth fund, provided by Valu-Trac Investment Management Limited.

Valu-Trac will change the objective and investment policy of the fund from **26 March 2026**. The old and new objectives and policies are overleaf for you to compare.

You may want to speak to your financial adviser about the impact of the change. Please speak to them before making any investment decisions, or if you have any questions about the change.

If you don't have a financial adviser, we recommend that you consider the benefits of receiving professional financial advice, which can be especially important when you need to make investment decisions. How the change will affect your account

- **The value of your holding** – The changes may affect the value of your fund holding. The costs associated with the change will be borne by the Investment Manager and the fund. This cost is estimated to be in the region of 0.004% of the fund's value.
- **Risk profile** – The fund's risk profile will not change.
- The Ongoing Charges Figure (OCF) / Total Expense Ratio (TER) will not change.

The OCF/TER represents the ongoing charges for the fund, expressed as a percentage. It is the sum of the Annual Management Charge (AMC) and all other running costs of the fund. OCF is increasingly replacing TER.

Why the change is happening

Valu-Trac is changing the investment objective and policy of the fund to more clearly articulate what the fund is trying to achieve and better describe how the fund is managed. The change is intended to ensure that there is standardised wording across the VT Momentum fund range.

The change to the investment policy is being made to provide investors with more detail and transparency about the kind of assets that the fund may invest in.

Old objective	New objective
To achieve capital growth over the long term (5 years) by investing in a balanced and well diversified portfolio of UK and International equities which the Investment Manager expects to grow in value as well as some fixed interest securities including government and corporate bonds.	To provide capital growth (generated through an increase in the value of the assets held by the fund and/or income received from those assets) over rolling 7 year periods, while maintaining a risk profile as defined by the portfolio's annualised ex ante volatility in the range of 10% to 14%. The fund aims to meet its investments objective by investing up to 85% of its assets, directly and indirectly, in the shares of companies based in the UK and internationally. The underlying companies in which the fund will be invested will be in any industry sector and of any size and the fund will have a low concentration of individual issuers. The other underlying assets in the portfolio will include real assets (property and infrastructure, indirectly through listed securities) and other diversifying assets (including indirect exposure to gold, alternative/uncorrelated strategies and managed futures strategies), fixed interest securities including government and corporate bonds, cash, near cash, deposits, money market instruments and money market funds.
