To Whom It May Concern,

This letter contains important information about your investment in one or more sub-funds of BNY Mellon Investment Funds (BNYMIF). No action is required from you.

In order to comply with naming and marketing rules under the UK SDR¹ we are changing the names and adding additional detail on the investment policies of the BNYMIF sub-funds listed below (the "Impacted Funds").

There will be no change to the investment objective, portfolio, or risk profile of the sub-funds as a result of these amendments.

1. Changes to Sub-Fund Names

As part of UK SDR, the FCA has introduced four sustainable investment labels (the "SDR Labels"). Under UK SDR, after 2 April 2025, a fund must apply a SDR Label if its name includes the term 'sustainable'.

As a SDR Label is not being applied to the Impacted Funds at this time, it is necessary to remove the word 'Sustainable' from their names.

The new names reflect the sustainability characteristics and responsible investment approach of the Impacted Funds and align to the naming and marketing rules under UK SDR.

2. Updates to Sub-Fund Investment Policies

The updated investment policies provide more detail on the Investment Manager's process for selecting assets in line with the sustainability characteristics. This includes information about the exclusions and frameworks, including metrics, used for selecting assets. The investment policies of the Impacted Sub-Funds detail the requirement for companies and/or corporate issuers to either contribute to or align with at least one of the specified sustainable themes and for sovereign issuers to align with the Investment Manager's proprietary sustainable framework. A summary of the current and revised investment policies is available at www.bny.com/investments/SDRupdates.

Under UK SDR, there is a requirement to produce a two-page consumer-facing information document for investment funds with sustainability characteristics. This summary document outlines the key sustainability characteristics of the Impacted Funds and will be available on our website from the effective date, 2 April 2025.

Copies of the revised Prospectus, the two-page consumer facing information document and the Key Investor Information Documents incorporating the updates described above will be available from our website, www.bny.com/investments from the 2 April 2025 or upon request. A list of impacted share classes is included under Appendix 1.

¹ Financial Conduct Authority's (FCA) Policy Statement on Sustainability Disclosure Requirements (SDR) and investment labels and related measurements (together known as UK SDR). UK SDR aims to improve the trust and transparency of sustainable investment products and reduce greenwashing.

We firmly support the aims of UK SDR and the importance of ensuring consumers have the right information to enable them to select products that meet their investment objectives. We understand that the Impacted Funds meet the established investment objectives of our investors including with regard to sustainability, notwithstanding a SDR Label is not being applied. As such we intend to continue to assess the application of the UK SDR to the Impacted Funds as it becomes more integrated into the product regulation for authorised funds.

No action is required from you. However, as we are not able to give you financial or investment advice, you should consult your financial adviser if you are uncertain as to how these amendments may affect you.
