Change of Annual Management Charge (AMC)

I am writing to you because you are invested in the Waverton Global Strategic Bond fund, provided by W1M Wealth Management Limited.

What is changing

W1M is proposing to increase the AMC for the fund from **16 July 2026**. Fund managers apply an AMC for the investment management they provide. This is reflected in the pricing of the fund and not taken directly from your holdings.

In addition, the performance benchmark for the fund will change to the ICE BofA Global Broad Market Index (GBP Hedged).

This proposal is subject to shareholder approval. If it isn't approved, we will write to let you know.

You may want to speak to your financial adviser about the impact of this change. Please speak to them before making any investment decisions, or if you have any questions about this change.

If you don't have a financial adviser, we recommend that you consider the benefits of receiving professional financial advice, which can be especially important when you need to make investment decisions. What this change means for you

This table shows the current and the new amounts once the change has completed.

*The Ongoing Charges Figure (OCF)/ Total Expense Ratio (TER) represents the ongoing charges for the fund, expressed as a percentage. It is the sum of the AMC and all other running costs of the fund. OCF is increasingly replacing the TER.

Please note that none of the changes detailed in this letter affect any charges made by Quilter.

Why the change is happening

The fund is the only sub fund of the company that has a performance related fee. Removing this, will simplify the fee structure and align the fund with the other sub-funds, thereby reducing operational complexity and improve shareholders' ability to compare the investment costs. It provides greater certainty and transparency by removing fee variability and capping the maximum fee payable to 0.75% of NAV.
