Portfolio objective

The portfolio aims to achieve capital growth over a period of five years or more, while managing the environmental, social, and governance (ESG) risk of the portfolio by investing in funds that demonstrate leading ESG integration.

The portfolio will have exposure to a diversified range of investments in the UK and globally. At least 70% of the assets in the portfolio will be invested in funds that demonstrate leading ESG integration (tier 2 funds) or target sustainable outcomes (tier 3 funds) as classified using our responsible investment tier framework.

The portfolio is matched to a risk profile that targets a specific range of volatility of between 75% - 85% of the expected annualised volatility of global equities over the next 10 years and is managed to stay within this range most of the time.

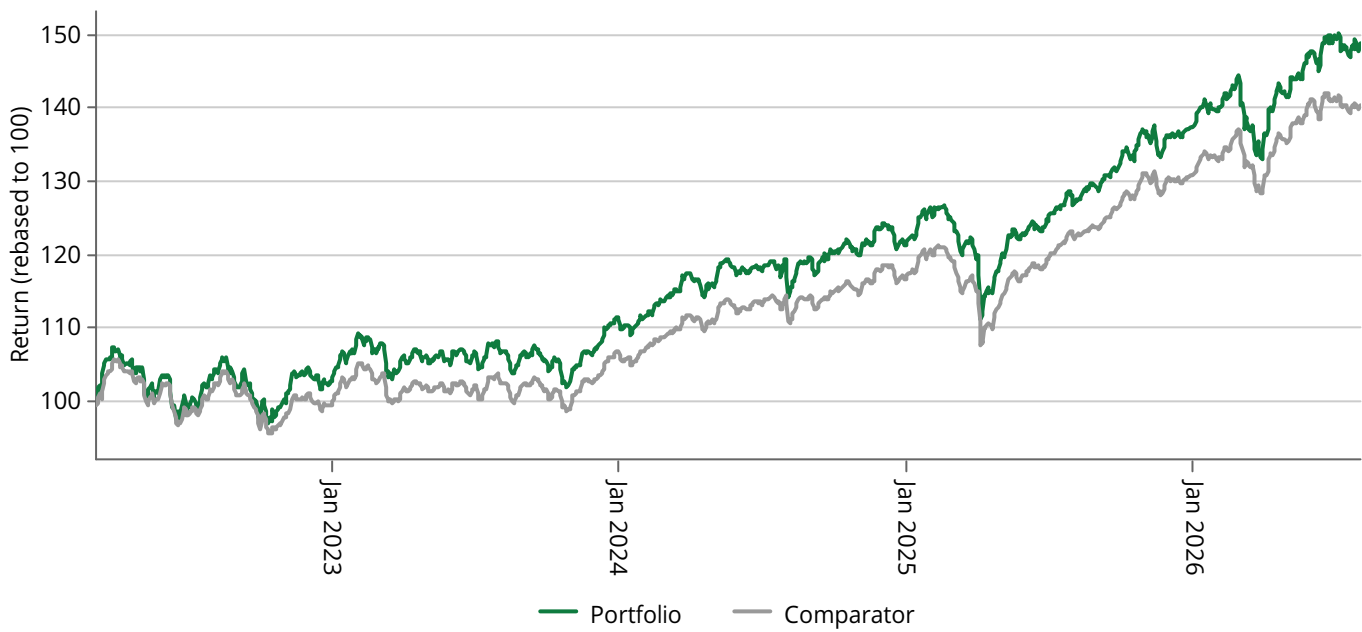

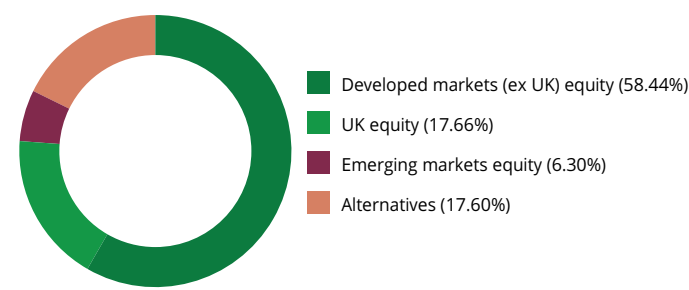

Glossary

Performance comparator

An index or similar against which we invite investors to compare the performance of the portfolio. The IA Flexible Investment sector is representative of funds with exposure to a broad mix of asset types. The allocation of the portfolio to these asset types may be different. Therefore, the performance of the portfolio and the performance comparator may differ significantly.

Volatility target

The portfolio targets a range of volatility rather than a particular level of growth. Volatility is a measure of how much the returns of an investment are likely to fluctuate over time. Higher volatility can indicate higher risk.

Weighted fund charge

The average of the charges of the funds held in the portfolio based on their weight within the portfolio.

MPS charge

The amount charged annually by Quilter for running the portfolio. The charge is expressed as a percentage of the investment held within the portfolio.
