## Why the change is happening

Pictet are planning to merge the Pictet Health and Pictet Human funds into a single, unified, strategy to be renamed 'Longevity'.

The Pictet Health fund will be renamed Pictet Longevity and the investment policy will be updated to be aligned with the investment strategy of the combined funds. The revised investment policy will be:

"The fund aims to achieve long-term capital growth by investing in companies that support and enhance longevity, as it pertains to individuals and society. The fund invests in companies that provide solutions to demographic shifts,

The OCF/TER represents the ongoing charges for the fund, expressed as a percentage. It is the sum of the Annual Management Charge (AMC) and all other running costs of the fund. OCF is increasingly replacing TER.
