How the conversion will affect your account

- The value of your fund holding the conversion will not affect the value of your fund holding.
- **Treasured assets** if you have treasured the fund to be excluded when deducting units to meet certain scheduled payments from your account (for example charges and ongoing adviser fees), this arrangement will stop. You can arrange to treasure different assets by providing us with a new treasured asset request form.

A note about cash in your account

We don't take any product or service charges on your cash balance (although the value is still included in the total value calculation for the charge). Instead, we pay you a rate of interest on cash in your account and we are paid by retaining a proportion of the interest we receive from our banking partners.

- The conversion will not change the funds risk profile.
- Ongoing Charge Figure (OCF) /Total Expense Ratio (TER) the OCF/TER will change with the conversion.

Fund managers apply an Annual Management Charge (AMC) for the investment management they provide. This is reflected within the daily price of the fund and not taken directly from your holdings.

The OCF/TER represents the ongoing charges for the fund, expressed as a percentage. It is the sum of the AMC and all other running costs of the fund. OCF is increasingly replacing the TER.

The table below shows the current and new AMC and OCF/TER.

New	0.65%	0.76%

Please note that none of the changes detailed in this letter affect any charges made by Quilter.

Why the funds are converting

First Sentier created the Z share class in 2021 to offer clients of an approved adviser reduced charges for a defined period. First Sentier can convert Z shares into B shares of the same fund as set out in their prospectus, and following a review, First Sentier have decided to convert the Z shares into B shares.



The next steps and avoiding the conversion

You do not need to take any action unless you would like to choose a new asset from our extensive range. You can switch your holding in the Stewart Investors Global Emerging Markets Leaders (Share Class Z) fund at any time up until **11:00 on 11 December 2025**. If you decide to switch into a new asset(s), please note that you will also need to update your asset choice for Direct Debit payments, if applicable.
