How this will affect your account

- The Annual Management Charge (AMC) of the fund will not change.

Why the change is happening

Following a recent review of the fund's positioning and evolving client needs, BNY Mellon have made the decision to rename the fund and remove the issuer and fund level net-zero emission targets. They believe these changes will increase the fund's marketability and lead to an increase in the fund's investment opportunities over the medium to long term.

The fund's investment policies have been updated to provide more detail in the Investment Manager's process for selecting assets in line with the sustainability characteristics. There is no change to the investment objective or portfolio of the funds as a result of these amendments.
