Found under the **'activity'** tab, on the clients dashboard or sub-account page, the Transfer Tracker allows you to view when an ISA, JISA, pension or Collective Investment Account transfer application has been received by us, requested from the ceding provider, and finally completed.

A summary of the total pending cash transfers for all clients within your business can also be found on the business performance screen, which you can access by clicking on the **'business performance'** button from our platform's homepage (see right).

Transfer stages

Each separate transfer will have its own entry on the 'activity' tab on a clients dashboard or sub-account page.



The Transfer Tracker will show a summary progress bar, **always coloured orange** (unless the transfer is rejected when it shows as red), showing the latest status of the transfer at that point in time.

- The orange status bar shows the transfer has been requested by Quilter.
- The blue comments box shows that we have sent a request to the current provider and we're waiting for their response.
- Clicking on the 'Transfer History' button will then show you an additional level of detail, which you can see an example of on the next page.

Tip: We will typically wait 25 working days before chasing a manual cash transfer or re-registration, after which any update will be provided on the Transfer Tracker.

Re-registration Transfer History

Here you can see an example of a re-registration involving four funds.

This screen shows:

- Details of when the re-registration was requested and the status of each fund.
- It includes details of whether the fund is offshore or not. An offshore fund can sometimes take longer to re-register due to additional administrative requirements.
- Where assets are received you also see a fund price and value.
- You can find out more information on the history of the transfer by clicking on the asset name.

Where Quilter offer a better value share class, we will convert clients to the new share class. You can find details of this in the column on the right and by clicking on the 'Share-class conversion' button. More details are on page 8.

Transfer rejected

- In the rare event a transfer is rejected you will receive details from us about why it's been rejected and what action you need to take.
- The progress status bar is red and the activity status shows **'rejected'**.
- This is the only time the status bar will show as any colour other than orange.
- The blue comment box details what action is needed to progress the transfer.

Please note that for ISA and CIA transfers involving re-registration, the Transfer Tracker may update to complete as soon as the first asset is received. Additional notes will be provided to confirm the status of the remaining assets and confirmation will be provided when all assets have been received.
