Dealing days and valuations: Regular valuations are made in respect of each fund on each Dealing Day as at the valuation point for each fund which will be at 12.00 noon (UK time). Each Business Day will constitute a "Dealing Day". Shares or units will be dealt at a price determined at the valuation point after the request for shares or units is received. Therefore, if a request is received after 12.00 noon on a Dealing Day it will be dealt with at a price determined on the next Dealing Day's valuation point.
Business day: for (i) Quilter Investors Global Equity Absolute Return Fund, a day (excluding Saturdays and Sundays) on which banks and stock exchanges are open for business both in Dublin and in London; and (ii) all other funds, any day on which the London Stock Exchange is open for normal business except for any day in respect of which Quilter Investors has notified the Depositary that

it is not open for normal business due to a concessionary company holiday or otherwise as agreed between Quilter Investors and

the Depositary.
